## **Stricter Texting and Driving Law**

A bill amending Ohio's texting-and-driving statute was passed into law, which will take effect in April.

Under the amended Revised Code section 4511.204, a person can now be stopped not only for texting while driving, but also simply for holding a telephone or electronic transmitting device. Other distractions while driving, such as scrolling social media or viewing videos, are prohibited under the statute. But exceptions exist, such as calling emergency services or talking on speakerphone.

The first penalty is a misdemeanor and carries up to two points on a driver's license plus a \$150 fine, while multiple offenses under the same section carry up to a \$500 fine and a driver's license suspension.

Prior to April, police will issue warnings. The state legislature hopes to curb needless deaths and injuries caused by distracted driving on Ohio roads.

#### LEGALESE: NUNC PRO TUNC

The phrase "nunc pro tunc," a Latin phrase translated as "now for then," denotes that an act has retroactive legal effect through a court's inherent power. Black's Law Dictionary 1097 (8th ed. 2004).

A lot of times, a "nunc pro tunc" motion is filed in court to fix a court order that has an inadvertent mistake to edit the order to make it as though it were intended to be.
