Three Changes to Social Security in 2023

This year will bring three major changes to Social Security.

First, the amount of money at which workers will be taxed is increasing from \$147,000 to \$160,200. This means that more money will be deposited into workers' Social Security accounts.

Second, seniors will receive a 8.7% cost of living increase.

Third, earning limits for senior retirees who are still working are going up to \$21,240 (if they don't hit full retirement age during the year) and \$56,520 (if they reach full retirement age during the year).

If you have any quesitons about your Social Security benefits, please call your local Social Security office. Many scammers send emails or make calls to people telling them they have an important update on their Social Security - merely to steal people's Social Security Numbers!

LEGALESE: SERVICE

This edition's legal word is "service." When someone files a complaint to begin a legal action, or responds to a complaint in an answer, all parties relevant to the action must be "served." Service is "perfected" (successful) when all necessary parties have received notice of the action. Service can be perfected via regular mail, certified/registered mail, or in-person. If service is not perfected, meaning a necessary party (e.g., defendant, co-defendant, involved social service agency) was not served, a court may not proceed on the action until all parties are served. A court may reschedule hearings or dismiss the case altogether!
